Filing for Patents

Applications may be made, in any language, a translation into Armenian is required after two months. The preliminary patent is issued on the applicant's responsibility without substantive examination. Such patent is valid for 10 years. Alternatively, the substantive examination may be requested within 9 years from the filing date of the application and should be based on the results of a substantive examination carried out by the Patent Office of another country, confirming the patentability of the invention.

The application is published after 18 months from the date of filing, or the earliest priority date, if priority has been claimed and is listed in the patent gazette. Early publication is available on request. Upon acceptance the grant is listed in the official gazette.

From 1 July 2021, new legislation abolished utility models in favour of short term patents of 10 years duration and enabled software to be patented.
