# Interim Report Results

These are the results of the Digital Accessibility Centre accessibility audit in line with WCAG 2.2 requirements measured against AA standard, along with the Revised Section 508 standards as published by the U.S. Access Board in the Federal Register on January 18, 2017, including the Corrections to the ICT Final Rule as published by the US Access Board in the Federal Register on January 22, 2018.

  - Enable Dictation
- Low Vision
  - System Inverted Colours
  - Magnification Features Android
- People who have a disability but do not require assistive technology

The following has been checked and reported on:

- Ability to interact with each step in each journey
- Ease of use and understanding
- Accessibility challenges
- WCAG 2.2 non-compliances



## Terms

The terms used in the Conformance Level information are defined as follows:

- **Supports:** The functionality of the product has at least one method that meets the criterion without known defects or meets with equivalent facilitation.
- **Partially Supports:** Some functionality of the product does not meet the criterion.
- **Does Not Support:** The majority of product functionality does not meet the criterion.

# Conclusion

The product is partially conformant with WCAG 2.2 AA. Most criteria are supported, with some exceptions.

During the second round of retesting the CampusM University App - Android , a smaller number of accessibility issues remained, but several were still identified by our analysts who rely on audio feedback to navigate and interact with page content.

For instance, some pages lacked proper heading structure, element states were not correctly communicated to screen reader users, inaccessible areas were still present, and issues with the logical focus order were observed.

Users relying on TalkBack were unable to access or interact with certain content within the App, leading to a confusing experience for blind and visually impaired individuals using the application.

Additionally, visually impaired users encountered difficulties due to poor colour contrast between text and background, as well as between non-text elements. These low-contrast combinations made it challenging to perceive content. Notably, these problematic sections appear to be part of third-party content and should be acknowledged in the accessibility statement.

Finally, the application did not support landscape orientation. This poses a barrier for users with mobility impairments who may prefer or require landscape mode to comfortably access content.
