### Kinds of Protection

Patents of Invention	Patents based on substantive examination are granted for a term of 20 years from filing date. Provisional patents based on formal examination are granted for five years with the opportunity of extension for a further three years
Extensions	Extensions of up to five years for pharmaceuticals or agrochemical products.
Utility models	Granted for a term of five years from the application date, with the possibility of extension for three years.
Industrial Designs and Models	May be registered

### Filing for Patents and Utility Models

Applications may be made, in Kazakh or Russian. The preliminary patent is issued after formal examination. Substantive examination on a patent may be requested by the applicant or a third party within 3 years from the filing date of the application (or 5 years if the provisional patent is extended).

The application is published after 18 months from the date of filing, or the earliest priority date, if priority has been claimed and is listed in the patent gazette. Early publication is available on request. Upon acceptance the grant is published and listed in the official gazette. Opposition may be filed at any time.
