Kinds of Protection

Patents of Invention	Granted for a term of 20 years from submission date
Extensions	Extensions of up to five years for pharmaceutical and phyto-pharmaceutical substances. A further six months may be granted for compounds for which paediatric studies have been made.
Utility models	Granted for a term of 6 years from the application date, extendable for a further 4 years.
Industrial Designs and Models	May be registered

Moldova is a validation state under the European Patent Convention. At the request of the applicant, granted European Patents may be validated in Moldova and will in principle have the same effect as granted national patents. Eurasian patents filed on or before 25 April 2012 are effective in Moldova.

Filing for Patents

Applications may be made, in any language, a translation into Romanian is required after three months.

The application is listed in the patent gazette after 18 months from the date of filing, or the earliest priority date, if priority has been claimed with an abstract in Romanian, English and Russian. Upon acceptance the grant is listed in the official gazette and published. Opposition may be filed within 6 months of grant.
