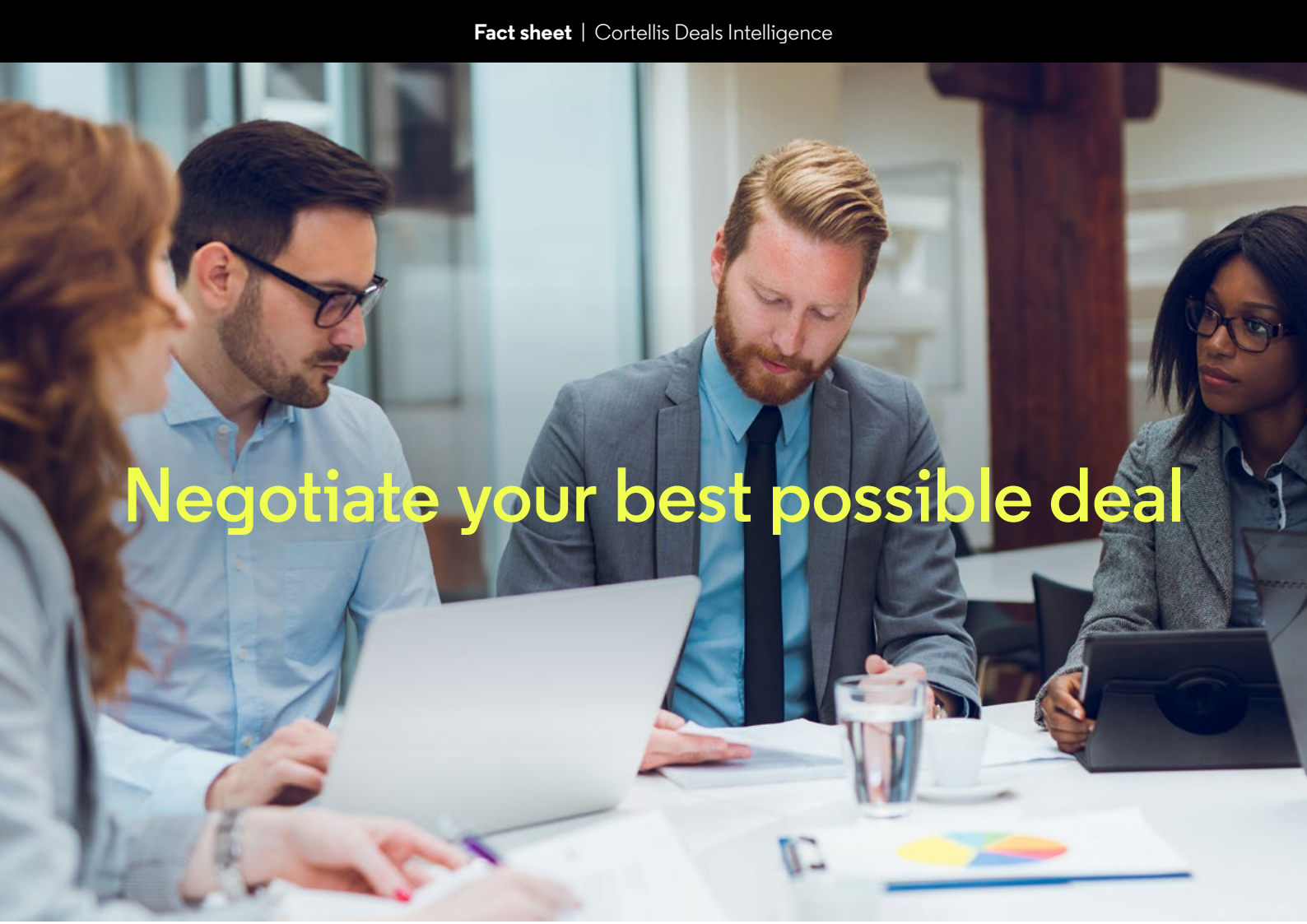

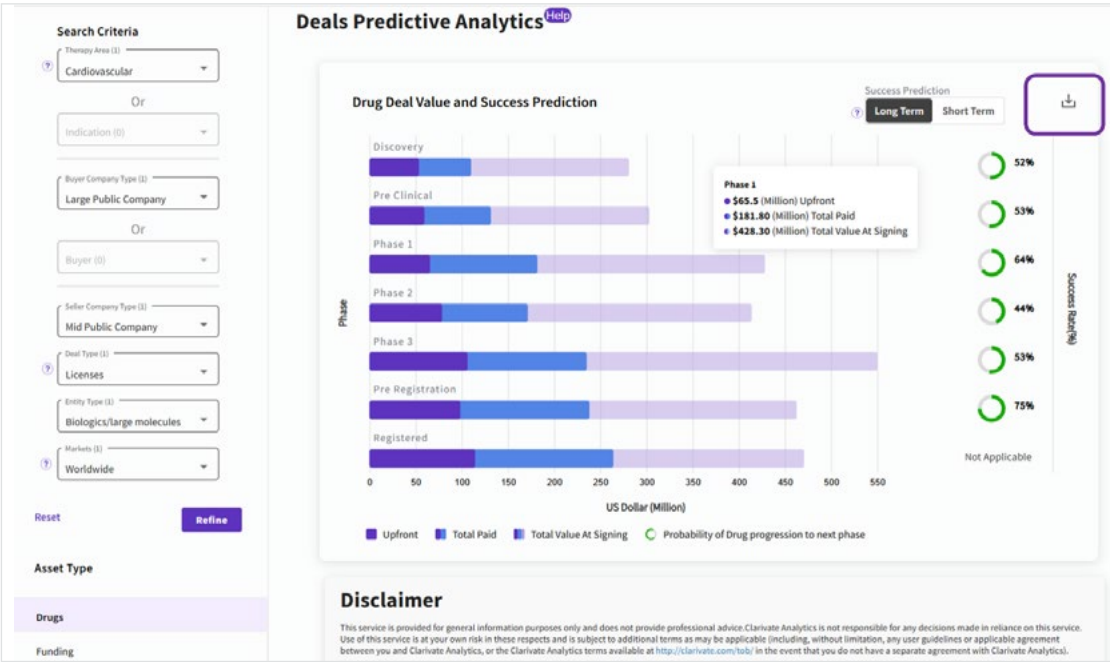
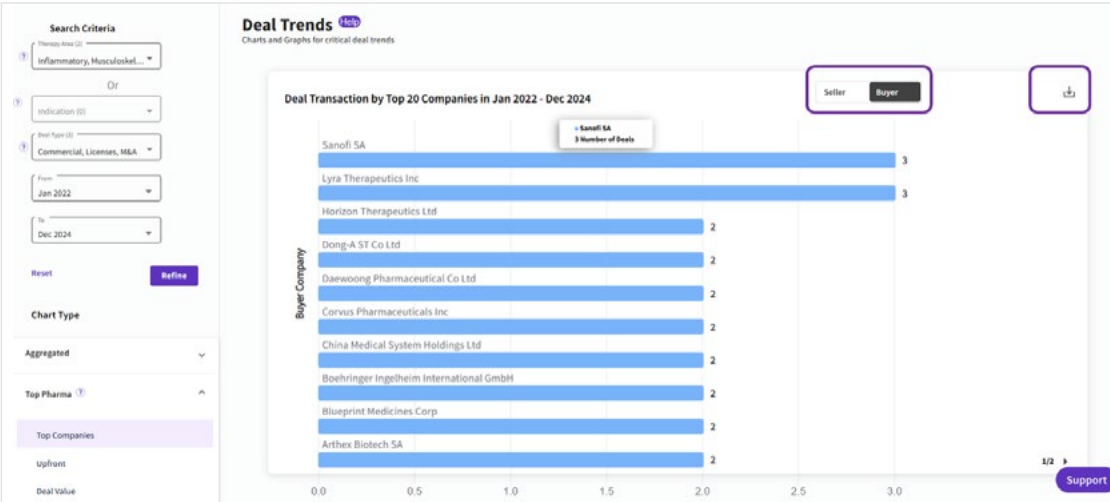


Figure 2: Easily identify top buyers or sellers by Therapy areas or Indications for all deal types.

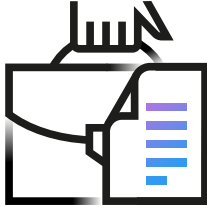
