

Navigating to related content types in Cortellis

Cortellis information is organized in different types of reports: Drugs, Companies, Deals, Clinical Trials and more. All of these reports are indexed by the editorial team and integrated to make it easy for users to find related information and learn more about:

- The company developing a drug
- Drugs being studied in a clinical trial
- Deals associated to a drug
- Drugs linked to a patent
- And more

This guide explains how to navigate around different content types in Cortellis.

1. From individual reports to related information

Users can navigate from a drug report to the report of the company currently or previously developing the drug with just one click from the 'Snapshot' tab, as shown next:

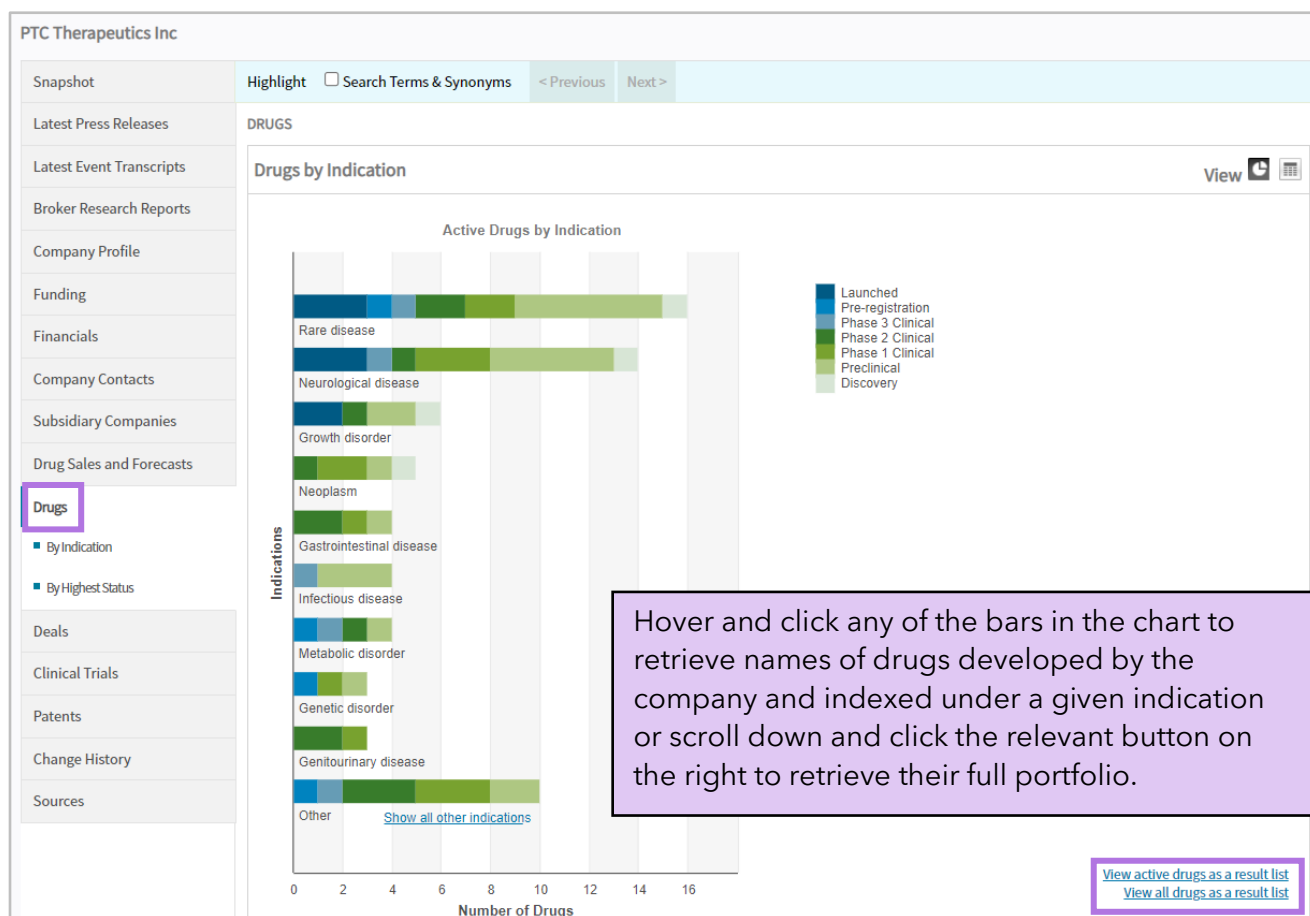

This will allow them to access the company's profile - created by the editorial team - and drug pipeline, to evaluate the company as a potential business partner or competitor.

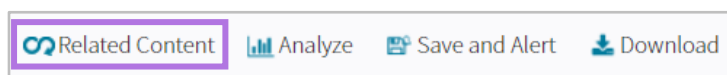
Similarly, users can retrieve the full list of drugs, deals, clinical trials, patents or press releases associated to a company from the relevant tabs in a Cortellis company report.



Patent and Deal reports also have links to related information in relevant tabs whereas Press Release, Conference and Clinical Trial reports display links to associated companies and drugs from the 'Snapshot' tab.

2. From result sets

Users can navigate from a result set displaying drugs, for example, to a different result set displaying clinical trials, companies or deals associated with those drugs simply by using the 'Related Content' button.

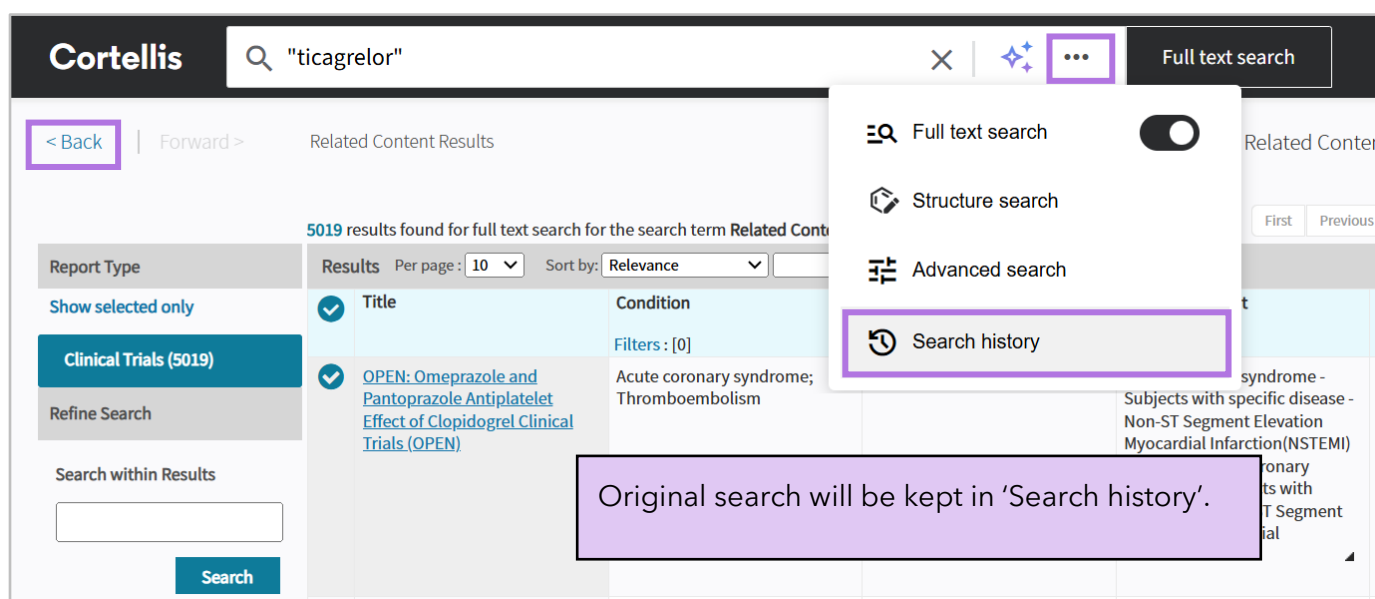
