

What is the Top 100 Global Innovators list?

- Top 100 Global Innovators 2022 from Clarivate recognizes the organizations that demonstrate consistent, above-the-bar innovation excellence and which sit at the very top of the global innovation ecosystem.
- Every year since 2012, Clarivate has celebrated the world's innovators in all their forms and flavors with our Top 100 Global Innovators list and corresponding report/analysis.
- As global ideation patterns change and the way they are measured evolves, the composition of the Top 100 Global Innovators list changes too. This year we introduce a **new methodology** – a model of excellence calculation focused on exceptional consistency and scale in innovativeness, where all ideas compete equally.
- There is no ranking within the Top 100 Global Innovators list recipients are listed alphabetically.



New methodology for 2022

Refreshed excellence calculation uses a twin track approach to evaluation:

First track: qualifying as global

We identify innovating organizations that pass qualification criteria based on **volume** of inventive activity:

- 500 published inventions since 2000
- 100 granted inventions in the
 2022 5-year evaluation window
- We then compare innovators based on the proportion and level of international inventions (ideas patented in more than one country or region), creating an international innovator weighting factor.

Second track: baselining each idea

We evaluate all inventions in the Derwent World Patents Index™ (DWPI™), and score them on four factors:

- INFLUENCE
- SUCCESS
- GLOBALIZATION
- TECHNICAL DISTINCTIVENESS


Each invention returns a Derwent Strength Index based on these four factors, compared directly to all other patented ideas.


Innovators are ranked based on the Derwent Strength Index of the invention in the middle of their activity over the last five years (the median average, the value separating the top performing half of their inventions from the bottom half), weighted by the global innovator factor.




Top 100 Global Innovators 2021 - earned media coverage

- Campaign experienced peak visibility at launch with 800 pieces of earned media coverage on launch day
- Sustained global media coverage throughout the year, both of the Top 100 Global Innovators program and recipient organizations
- Top 100 Global Innovators 2021 has achieved more than 2,300 pieces of coverage since launch last February






